	I accept that chicks and developing embryos need to be treated carefully and respectfully and not subjected to ANY unsatisfactory conditions, including periods of cooling or handling outside of that authorized by a MiniHatch representative.
	I guarantee there will be no damage to any equipment, and all materials provided will be cared for and used respectfully. I understand that charges may apply for damaged equipment or equipment not returned in original condition.
	I understand that my desired start date may be affected by the availability of hatching eggs. MiniHatch will do their best to facilitate my start date, but due to the natural system in which the birds exist, eggs may not be available in supply on my preferred dates.
	I realize that there may be situations in which no eggs develop, or results are not what I expected. I understand that MiniHatch will do their best to provide fertile and hatchable eggs, but nature is beyond our control and sometimes situations arise that end in poor results.
